9. PETRONET INDUSTRIAL SOCIETE ANONYME OF COMMERCE – PRODUCTION OF CHEMICAL PRODUCTS with distinctive title PETRONET S.A.

with the composition of a new company named “NEOCHIMIKI INTERNATIONAL SOCIETE ANONYME HOLDING INDUSTRIAL AND COMMERCE COMPANY OF CHEMICAL PRODUCTS”. As of 21.05.2007 the above nine merged companies are dissolved, while in their rights and liabilities the newly composed company “NEOCHIMIKI INTERNATIONAL ANONYMOUS HOLDING INDUSTRIAL AND COMMERCIAL COMPANY OF CHEMICAL PRODUCTS” enters henceforth.

After the 5.06.2007 the above nine merged companies are no longer taxable.
